Advertising and Promotion. CGCOA shall use its best efforts to provide the following rights to Sponsor during the Term of this Agreement.

Benefits of Sponsorship. Sponsor benefits will be provided as described in the document entitled, "CGCOA Sponsorship Program."

Sponsor Insurance. During the term of this Agreement, Sponsor agrees to carry workers' compensation and employer's liability insurance in such amounts as may be required by law for any personnel Sponsor may utilize for the delivery, installation, maintenance, repair and removal of the products.

Option to Renew. CGCOA grants to Sponsor the right to renew its Sponsorship annually at the sponsorship rates in effect at the time of renewal and determined by CGCOA.

Term & Termination. This Agreement shall become effective on the date first written, and shall expire one year from this date unless earlier terminated or renewed.

Sponsor References. The CGCOA Board of Directors reserves the right to evaluate and vet potential sponsors to ensure that businesses desiring to affiliate with CGCOA are reputable, perform their duties as promised, and in good standing with creditors. This evaluation process could take up to two (2) weeks, and if CGCOA rejects the proposed sponsor as a result of the evaluation process, all sponsorship dues paid will be fully refunded.
